19th Asian Games Hangzhou 2022 Sailing Competition

**19 to 27 September 2023
Ningbo Sailing Center,
Hangzhou, China**

The Organizing Authority (OA) is the 19th Asian Games Hangzhou Organizing Committee, in conjunction with the Olympic Council of Asia (OCA) and the Asian Sailing Federation (ASAF).

1. RULES

1.1 The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS). Other documents under RRS Definition Rule (g) include:

- 1.1.1 [DP] [SP] The 19th Asian Games Hangzhou 2022 - Equipment Regulations (ER).
- 1.1.2 [DP] The 19th Asian Games Hangzhou 2022 - Support Team Regulations (including Support Vessels) (STR).
- 1.1.3 [NP] [DP] [SP] The 19th Asian Games Hangzhou 2022 - Athlete Media Regulations (AMR).
- 1.1.4 [DP] The 19th Asian Games Hangzhou 2022 - Competition Area Regulations (CAR).
- 1.1.5 For Medal Races and Windsurfing Medal Series races, World Sailing Appendix MR Umpired Medal Racing available on the World Sailing website (www.sailing.org) applies and changes a number of racing rules. A link to the version that is current when the regatta begins will appear in the Sailing Instructions.

1.2 The Olympic Council of Asia (OCA) constitution, rules and its by-laws will apply. If there is a conflict between the OCA rules and World Sailing, the World Sailing constitution and regulations shall apply.

1.3 No National Authority prescriptions will apply.

1.4 In all rules governing this regatta,

- 1.4.1 Both “athlete” and “competitor” mean a person competing, or intending to compete, in the regatta.
- 1.4.2 [SP] denotes a rule for which a standard penalty may be applied by the Race Committee or Technical Committee without a hearing or a discretionary penalty applied by the International Jury with a hearing (this changes RRS A5.1); and
- 1.4.3 [NP] denotes a rule that shall not be grounds for protests by a boat and for which the International Jury may refuse to hold a hearing. This changes RRS 60.1(a) and 63.1.
- 1.4.4 [DP][NP] Protocols relating to COVID-19 may be published at any time and will state if they have the status of a rule. All participants (competitors, support persons and officials) are expected to follow these

protocols. Breaches of these and any event Covid protocols (published on the event website and issued as an attachment to the SI) may be misconduct and subject to RRS 69.

1.5 The Equipment Rules of Sailing (ERS) will apply.

1.6 RRS Appendix P, Special Procedures for Rule 42 will apply.

1.7 For the Men's Skiff, Women's Skiff and Mixed Multihull, RRS 44.1 and RRS P2.1 are changed so that Two-Turns Penalty is replaced by a One-Turn Penalty.

1.8 In RRS 44.2 insert after the first sentence: 'However, if Mark 1a is set, a boat may take a penalty for an incident in the zone around Mark 1 or on the leg between Mark 1 and Mark 1a, as soon as possible after leaving the zone around Mark 1a'.

1.9 For Medal Races and Windsurfing Medal Series races, World Sailing Appendix MR Umpired Medal Racing available on the World Sailing website (www.sailing.org), applies and changes a number of racing rules. A link to the version that is current when the regatta begins will appear in the Sailing Instructions.

1.10 For the Men's and Women's Kite events, RRS Appendix F applies.

1.11 For the Men's and Women's Windsurfing and Windsurfer RS:X events, RRS Appendix B applies except that RRS B5 61.1 is deleted.

1.12 RRS 90.3(e) shall apply.

~~1.13 Class rules regarding class association membership and its championship rules will not apply.~~

1.14 For Men's and Women's Kiteboarding events: damaged and lost kites shall only be replaced with Kites of the same brand, make and size.

1.15 If there is a conflict between languages the English text will take precedence.

2. [DP][NP] EVENT ADVERTISING

2.1 Athletes advertising will be restricted to World Sailing Regulation 20, Advertising Code.

2.2 Boats may be required to display advertising supplied by the Organizing Authority.

2.3 While afloat, athletes may be required to wear bibs provided by the Organizing Authority over their PFD.

3. COMMUNICATION

3.1 The Official Notice Board is located on the website at <https://www.hangzhou2022.cn/En/>.

3.2 [DP]The 19th Asian Games Hangzhou 2022 Support Team Regulations will be available no later than the 1st August 2023 on the Official Notice Board.

3.3 [DP]The 19th Asian Games Hangzhou 2022 Competition Area Regulations and the 19th Asian Games Hangzhou 2022 Official Vessel Regulations will be available no later than the 4th September 2023 on the Official Notice Board.

3.4 [DP]The 19th Asian Games Hangzhou 2022 Athlete Media Regulations will be available no later than the 4th September on the Official Notice Board.

3.5 [DP]The 19th Asian Games Hangzhou 2022 Equipment Regulations will be available no later than the 1st August 2023 on the Official Notice Board.

3.6 Other documents governing the regatta will be published on the Official Notice Board no later than 4th September 2023.

3.7 From the first warning signal until the end of the last race of the day, except in an emergency or when using equipment provided by the race committee or Organising Authority, a boat shall not make voice, radio or data transmissions and shall not receive voice, radio or data communication that is not available to all boats. This restriction also applies to mobile telephones.

4. ELIGIBILITY, ENTRY AND REGISTRATION

4.1 The regatta consists of 14 Events, including six (6) Men's Events, six (6) Women's Events and two (2) Mixed Events as follows:

4.2 Athletes in the Boy's and Girl's Dinghy Events shall be born in 2006 or later. Proof of age will be required at registration.

4.3 Athletes and their support team shall be entered via their respective National Olympic Committees (NOCs) affiliated with the OCA. The Member National Authorities (MNAs) of those NOCs shall be in good standing with World Sailing and ASAF, failing which they will not be eligible to enter the Regatta.

4.4 Unless otherwise approved in writing by the OCA and World Sailing together, each athlete shall be a national of the country they represent (see World Sailing Regulations 19.8 to 19.18). Each athlete shall provide proof of their nationality during registration and whenever requested by World Sailing.

4.5 World Sailing Eligibility under World Sailing Regulation 19 is required. Each athlete shall be registered as a World Sailing Sailor on the World Sailing website.

4.6 Each NOC may enter one (1) boat per Event. For the Mixed Events, each athlete from each Event shall be of different genders. The total number of athletes per NOC shall not exceed 18 (nine men/boys and nine women/girls).

4.7 Entries shall be submitted by each NOC in accordance with OCA directions and sending it to sports entry team (E-mail: sportentry@hangzhou2022.cn), considering the following deadlines (Beijing time, GMT +8):

4.7.1 Entry by Sport – 24:00 February 20 2021

4.7.2 Entry by Number – 24:00 March 15 2023

4.7.3 Entry by Name – 24:00 July 15 2023

Any late forms, additional applications or other alterations shall not be accepted after this time.

4.8 Crew substitution is not permitted except in case of proven injury or illness and approved by the Organizing Authority in writing prior to the end of the first team leaders meeting.

4.9 Athletes and their support team shall complete registration at the registration desk in the venue from 0800h to 1800h on 19-20 September 2023. Each NOC shall be accompanied by a team leader, who may complete the registration on behalf of the NOC with all necessary

documents. Athletes who have not registered within this period may not be allowed to participate in the regatta.

4.10 Only accredited athletes and support team persons shall have access to the venue and residential areas.

4.11 For the purpose of the RRS Definition, a Support Person includes any person holding accreditation for the regatta. The NOC shall nominate their Support Personal.

4.12 The Medical Treatment Permission and Medical History forms shall be submitted for each athlete no later than the close of registration. This form does not give dispensation for taking prescribed medication. For medication declarations, please follow procedures as given in the World Sailing Anti-Doping Code (World Sailing Regulation 21).

5. FORMAT

5.1 The regatta will consist of an opening series and, provided a minimum of 6 races have been completed in the opening series, a medal race or medal series for Olympic

Qualifier events. The top ten ranked boats at the end of the opening series of each event will progress to the medal race or medal series. The opening series may be extended if less than 6 races have been completed, with the marathon race counting as 2 races for the purposes of this clause.

5.2 Race management may not hold medal series and medal races for events where there are less than 10 entries.

6. SCHEDULE

6.1 The schedule is as follows:

6.2 From 20 to 27 September 2023, there will be a daily team leaders meeting/coaches meeting at 0900h. The location will be defined in the Sailing Instructions.

6.3 No warning signal will be made after 1700h on each competition days except on 27 September 2023 in which no warning signal will be made after 1400h.

6.4 The Race Committee may change the schedule to bring forward any number of races. The Race Committee may schedule racing on a reserve day.

7. [DP][SP][NP] EQUIPMENT INSPECTION

7.1 This regatta is an international event for the purpose of RRS G1.1.

7.2 A Technical Committee shall be appointed in accordance with RRS 92.

7.3 Boats shall be available for inspection in accordance with Notice of Race 6.1 and the Equipment Inspection Schedule.

7.4 The procedures for inspections will be specified in the 19th Asian Games Hangzhou 2022 Equipment Regulations.

7.5 The fact that race officials may conduct inspections of a boat does not reduce the responsibilities of each competitor set out in the rules.

7.6 470 boats shall produce a valid measurement certificate, which for the 470 Class includes the completed measurement form. RRS 78.2 is deleted and replaced by: “When a rule requires a valid certificate to be produced or its existence verified, the certificate must be produced before the boat races. If the certificate is not produced or verified before the boat races, the boat shall be disqualified from all races of the event unless the International Jury is satisfied there are exceptional circumstances.”

7.7 Class Insignia, National Flag and National Letters (No Sail numbers) are mandatory and to be present on equipment as specified in each respective class rule.

8. SAILING INSTRUCTIONS

8.1 The Sailing Instructions will be first published after 1 August 2023 on the ONB.

9. VENUE

9.1 The Sailing competition will take place at the Ningbo Xiangshan Sailing Center. See Addendum 2.

9.2 The racing area will be the waters in front of the venue. See Addendum 3.

10. THE COURSES

10.1 The course will be windward/leeward, slalom, marathon or trapezoid variants with optional finishing legs.

10.2 The target times in minutes are:

11. INTERNATIONAL JURY

11.1 An International Jury will be appointed in accordance with RRS 91(b). Its decisions will be final as provided in RRS 70.5.

12. SCORING

12.1 RRS Appendix A will apply. RRS B8 is deleted.

12.2 3 races is required to be completed to constitute the regatta.

12.3 For Men's, Women's, Boys, Girls and Mixed Dinghy, Men's and Women's Skiff, Men's and Women's Windsurfer RS:X and Mixed Multihull Events:

12.3.1 When three or more opening series races have been completed, a competitor's score will be the total of her race scores excluding her worst score. However, the score from any medal race shall not be excluded.

12.3.2 In medal races, a boat's score shall be double the number of points specified in RRS Appendix A4, with any [SP] then added.

12.3.3 Ties in the series score between boats with different medal race point scores shall be broken in favour of the boat that scored lower in the medal race. This changes RRS Appendix A8. If a tie remains, ties in the regatta score are broken by applying RRS A8.1 to the opening series scores.

12.3.4 The boats assigned to compete in the medal race will be ranked highest in the regatta except for a boat disqualified from the medal race under rule RRS 6 or 69.

12.4 The scoring for Windsurfing and Kite Events will be defined in the Sailing Instructions.

13. [DP][NP] SUPPORT TEAMS (INCLUDING SUPPORT VESSELS)

13.1 A support vessel includes any vessel that is under the control or direction of a support person (as defined in the RRS), including any person gathering data that may be used at later time.

13.2 No more than one support vessel per National Olympic Committee per Event entered may be registered. Support vessels are permitted to carry one or more support persons from other competing National Olympic Committee that do not have a registered support vessel for that Event.

13.3 Support vessels shall be registered at the register desk on the Registration Day. The Organizing Authority may, at its discretion, refuse to register support vessels not deemed to be suitable.

13.4 Support vessels shall display the 3 letter code of their NOC clearly visible on both sides of the vessel in strongly contrasting colours at all times while afloat. The minimum height for the letters shall be 200mm.

13.5 It is mandatory that PFDs shall be worn by all personnel on board support vessels at all times when afloat.

13.6 For safety reasons, support vessel shall carry on board: PFDs, VHF radio., first-aid kit, whistle, tow rope, adequate anchor and tackle, engine safety cut out switch and tether (kill chord) and adequate fuel.

13.7 The engine safety cut out switch and tether (kill chord) shall be securely attached to the driver at all times when the engine is running and in gear. It is strongly recommended that the kill chord is used at all times when the engine is running.

13.8 The use of support person's drone is prohibited.

14. PRIZES

14.1 Gold, Silver and Bronze medals will be awarded to the athletes ranked top three in each Event.

14.2 Other prizes may be awarded at the discretion of the Organizing Authority.

15. DOPING CONTROL

15.1 Athletes are reminded of the World Sailing rules and regulations concerning the use of banned methods and substances, which are contained in World Sailing Regulation 21, Anti-Doping Code.

15.2 Doping control may take place during the regatta.

16. RISK STATEMENT

16.1 Competitors and support persons participate in the event entirely at their own risk. **Rule 3** of the RRS states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

16.1.1 They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;

16.1.2 They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;

16.1.3 They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;

16.1.4 By participating in any race, they are satisfied that their boat is in good order, equipped to sail in the event and they are fit to participate;

16.1.5 The provision of a race management team, patrol boats, umpires and other officials and volunteers by the organizer does not relieve them of their own responsibilities;

16.1.6 The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.

16.1.7 It is their responsibility to familiarize themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.

17. [DP][NP] INSURANCE

17.1 Each 'person in charge' (as defined in RRS 46) shall hold a valid insurance certificate showing proof of third-party liability coverage of at least USD 250,000 per incident.

17.2 Each support vessel shall have a valid insurance including third party liability coverage of at least USD 250,000 per incident.

17.3 The Organizing Authority is not responsible for verifying the status or validity of certificates. The Organizing Authority will not arrange insurance for NOCs who fail to arrange their own insurance.

18. [DP][SP][NP] MEDIA RIGHTS, CAMERAS AND ELECTRONIC EQUIPMENT

18.1 By participating in this competition, athletes and their support person automatically grant to the Organizing Authority, Asian Sailing Federation, World Sailing and their sponsors, the right in perpetuity to make, use, and show, from time to time at their discretion, any motion pictures and live, or recorded television and other reproductions of them during the period of the competition without compensation.

18.2 Boats and athletes may be required to carry cameras, sound equipment or positioning equipment as specified by the Organizing Authority.

18.3 The equipment provided, once placed on the boat as instructed by the Organizing Authority, shall not be manipulated by the athletes or the support person in any way.

18.4 Athletes may be required for interviews at the regatta.

19. AMENDMENTS TO THE NOTICE OF RACE

19.1 This NoR may be changed. Changes will be posted on the regatta website.
